- When using spray cleaners, spray the cleaning solution onto a soft cloth or sponge, never directly onto the Hansgrohe products, as the atomised spray could enter openings and gaps in the Hansgrohe products and cause damage.
- After cleaning rinse thoroughly with clean water to remove any cleaner residue.
- The use of steam cleaners is not permitted. The high temperatures can damage the products.


